On November 19, 2021, I wrote to you identifying a bilingual judicial vacancy in Cornwall with a specialty in criminal law matters. I received the Committee's recommendations for filling this vacancy on July 15, 2022.

I thank you and the Committee for your hard work and dedication in providing these recommendations. I recognize the significant time and effort that a fair and rigorous recommendation process demands.

However, in accordance with section 43.1 (8) of the *Courts of Justice Act*, I would like to request that the Committee provide me with a new ranked list of candidates whom the Committee recommends for filling the vacancy in Cornwall.

As previously mentioned, this vacancy is to be filled by a bilingual judge who will preside in the area of criminal law. I would also note that this position involves travel within the East Region and elsewhere in the Province of Ontario.

I would appreciate it if you could take the necessary steps to identify a new list of suitable candidates to fill this vacancy as soon as possible.
