# Digitize hiring and onboarding one step at a time

## Step 1 Sending the offer letter

With manual offer letters, the onerous task of tracking down approvals and signatures can result in delays that dampen candidate interest. A signed offer then triggers alerts to management and HR. Onboarding data is automatically transferred to your HRIS then prompts the next downstream process.
