Data Protection Clause

- 1. For the purposes of this clause the following terms shall have the meanings set out below, which are the meanings given to them in the Data Protection Act 1998:
- "Personal Data" means data which relate to a living individual who can be identified:
- a. from those data, or
- b. from those data and other information which is in the possession of, or is likely to come into the possession of, the Data Controller, and includes any expression of opinion about the individual and any indication of the intentions of the Data Controller or any other person in respect of the individual; "Data controller" means a person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any Personal Data are, or are to be, processed. We collect Personal Data from communications with Our policyholders including in particular in connection with claims under insurance policies. We act as a Data Controller for all Personal Data We obtain from
- Our customers and prospective customers and comply with Our obligations under the Data Protection Act 1998.
- 2. We may disclose the Personal Data we obtain from policyholders to other members of the Ironshore Group in connection with the provision of products and services offered by the Ironshore Group and may also disclose the Personal Data to Our subcontractors, service providers and agents in connection with the provision of goods and services to the Ironshore Group and its customers. Whenever it is necessary for Us to share Your Personal Data with others, we will only do so on the basis that the Personal Data will be handled confidentially.
- 3. In order to prevent and detect fraud we may at any time share information about You with other organizations and public bodies including the police, undertake credit searches and additional fraud searches, and check and/or file Your details with fraud prevention agencies and databases, and if You give Us false or inaccurate information and We suspect fraud, We will record this.

Ironshore Group and other organizations may also search these agencies and databases to:

- a. Help make decisions about the provision and administration of insurance, credit and related services for You and members of Your household;
- b. Trace debtors or beneficiaries, recover debt, prevent fraud and to manage Your accounts or insurance policies;
- c. Check Your identity to prevent money laundering, unless You furnish Us with other satisfactory proof of identity; and We can supply on request further details of the databases We access or contribute to.
- 4. The recipients of Personal Data from Us may be located outside the European Economic Area in countries which do not have the same level of legal protection of Personal Data as the European Union, and where We provide Personal Data to parties in such countries We will have in place agreements under which the recipient agrees to protect the Personal Data to standards which are acceptable to Us, including in relation to confidentiality.
- 5. Where a person provides Us with Personal Data about any other individual, he or she warrants that they have full rights to disclose the Personal Data to Us to use for the purposes for which it is disclosed.
