## Summary of cover

- Third party property damage caused by commercial vehicle limit now £10M (can be extended to £35M)
- Third party property damage limit caused by carriage of hazardous goods is now £1M
- Enhanced new car replacement. Now also applies to all vehicles not just cars (cover limited in respect of commercial vehicles and special types)
- Accessories including visual equipment limit increased from £250 to £5,000
- Medical expenses limit increased from £250 to £500
- Personal effects limit increased from £100 to £500
- New improved trailer section
- Unlimited loss or theft of keys (was £500)
- Emergency Overnight Accommodation up to £500 for all occupants
- Communication up to £100,000 if an insured accident threatens adverse publicity
- Legal Expenses cover of up to £100,000 per claim to pursue the recovery of damages following a road accident that causes death or bodily injury to your drivers and authorised passengers or damage to your vehicle or property contained in it.
- Legal advice on any business-related matter, 24 hours a day, 365 days a year.
