Covered events

Extortion

Payment demands following a threat to: injure, kill, or kidnap an Insured Person; damage property; contaminate products; divulge trade secrets or destroy electronic data by computer virus.

Detention

The holding under duress of an Insured Person for whatever reason, other than Kidnap, and irrespective of whether such holding under duress is by legal governmental authorities in the place of custody or by other parties.

Kidnap

A seizure or detention of an Insured Person for the purpose of demanding ransom monies.

Hijack

The illegal holding under duress, for a period in excess of four consecutive hours, of an Insured Person, while travelling by any form of transportation or when forcibly removed from that mode of transportation.
