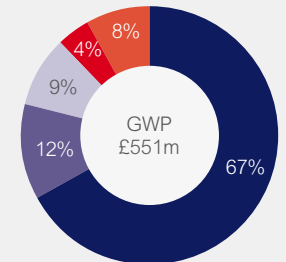
2017 Gross written premium by strategic business unit

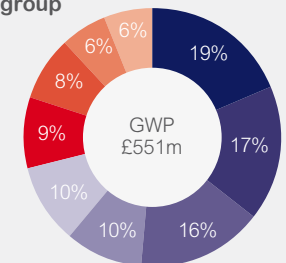
2017 M&A Gross written premium by geography
