Professional Indemnity

This leaflet provides a summary of the significant features, benefits and limitations of the cover provided by Zurich Insurance plc Professional Indemnity policy for contractors. The full terms, conditions and exclusions are shown in the policy document. If you want to see full details of the cover, please refer to the policy document.

Type of insurance and cover

This policy provides breach of professional duty cover for incorrect professional services provided by or on behalf of contractors.

The standard duration of this non-investment insurance claims made contract is 12 months.

Significant features and benefits

- Limits of indemnity up to £10 million.
- Liability arising out of the provision of professional services.
- Libel and slander.
- Breach of confidentiality.
- Unintentional breach of copyright.
- The consequence of any loss of or damage to business records.
- Adjudicator awards.
- Costs and expenses incurred to mitigate a loss or potential loss that may otherwise result in a claim.
- Duty to warn of defects in the professional services of others.
- Costs of defending criminal proceedings.
- Collateral warranty cover with no assignment limitation.
- Loss of documents covers expenses incurred in replacing or restoring lost or damaged records associated with your services or for which you are responsible.
- Cover for costs of representation at any official examination or enquiry into your affairs.
- First Party Copyright Infringement covers expenses incurred for any injunction or for damages for infringement of any copyright vested in you.
- Innocent Non-Disclosure cover.

Significant and unusual exclusions or limitations

- Asbestos (although restricted cover is provided subject to a maximum limit of £1,000,000 depending on policy limit).
- Claims brought within the United States of America or Canada.
- Work done prior to the retroactive date.
- Prior circumstances and claims.
- Pollution or contamination although restricted cover is provided up to the policy limit.
- Financial investment advice.
- Liability arising out of the supply, manufacture, sale or distribution of defective materials, goods, equipment or products.
- War or terrorism related events.
- Claims arising from any valuation report unless for the purpose of measuring quantities or certifying payments due to contractors

Insurance Act 2015

This policy is compliant with the principles of the Insurance Act 2015 law reforms. It also incorporates an 'opt out' which aims to promote good customer outcomes. We have opted-out of the 'proportionate reduction of claim remedy' available to insurers under the Act. This means that in cases of non-disclosure or misrepresentation which are neither deliberate nor reckless, if we would have charged an additional premium had we known the relevant facts, we will charge that premium and pay any claims in full rather than reducing claims payments in proportion to the amount of premium that would have been charged.

We believe that our 'additional premium approach' should, in most situations, be more favourable to our customers when compared to the proportionate reduction of claim remedy. Our additional premium approach does not affect our right to apply the other remedies available under the Act for non-disclosure or misrepresentation.

Cancellation rights

This policy does not entitle you to a cooling off period.

We will let you know if we believe the ombudsman service can consider your complaint when we provide you with our decision. The service they provide is free and impartial, but you would need to contact them within 6 months of the date of our decision.
