Loss of or damage to the Goods described in the Schedule whilst in Transit within Australia. The Transit Clause is broadly defined on a "floor to floor" basis and specialist loading/unloading provisions are incorporated for livestock and motor vehicle transportation.

Options are available for Accidental Damage or Specified Events. The former includes insufficiency of packaging cover where carried out by a third party or where You have packed the goods yourself and have taken all reasonable precautions and there is no lack of due care.

Cover B	Specified events cover. Automatically includes theft of Insured Goods from the Conveying Vehicle following forcible and violent entry, pilferage or non-delivery.
