## Coverage for internet connected households

Privacy remains a major concern for homeowners and tenants, and many are looking for a way to protect that privacy with meaningful, reliable insurance protection. This concern is growing quickly for several reasons:

- People who hold the personal information of others may wish to notify those affected if such information is lost or stolen.
- The rapid growth in connected home technology and smart devices is creating increased need to protect data, systems and software from computer attacks.
- Criminal activities like cyber extortion, cyberbullying and online fraud – also threaten homeowners and tenants with financial loss.

#### Coverage for cyberbullying

#### Highlights of coverage

HSB Home Cyber Protection adds significant cyber insurance coverages to a traditional homeowners insurance policy:

- Pays to recover data and restore systems that have been lost or damaged due to a cyber attackincluding attacks involving malware or unauthorized use of owned or leased computers, mobile devices and connected home devices.
- Provides payments and professional assistance in responding to Cyber Extortion demands based on a credible threat to damage, disable, deny



access to or disseminate content from devices, systems or data.

- Covers losses resulting from cyberbullying, including mental health services, social monitoring technology, legal and relocation expenses, professional cybersecurity consultation, and lost wages.
- Notifies and pays for services to affected individuals in the event that private personal data entrusted to a household resident is breached. (Note: Does not protect an insured in the event their own personal information is breached; coverage is for others only.)
- Covers online fraud that results in a direct financial loss to a covered policyholder.
- Offers available limits of either \$25,000 or \$50,000, at a \$500 or \$1,000 deductible.
- Requires that triggering event be discovered during the policy period and reported within 60 days.
- Contains certain exclusions described in policy documents.
