Miscellaneous Professional Liability insurance provides coverage for any errors or omissions (E&O) arising from the unique professional services that a policyholder provides to clients and other third-parties, typically excluded under a general liability policy.

Coverage is designed to protect the policyholder's business against claims or suits if the professional advice or services provided caused a third party financial harm arising out of a wrongful act (any negligent act, error, or omission) by any Insured in rendering or failing to render Professional Services to others for a fee or other remuneration.
