NOTICE OF SETTLEMENT

Plaintiffs Jennifer Baker and Jean Greenberg and Defendants John Hancock Life Insurance Company (U.S.A.) and the John Hancock US Benefits Committee (collectively, the “Parties”), have reached a settlement in principle of the above captioned action on a class-wide basis. The Parties expect to be able to finalize a comprehensive settlement agreement and file a motion for preliminary approval on or before June 1, 2021. In the meantime, the Parties request that all pending proceedings and deadlines continue to be stayed.¹
